# Writing your Will



## Deciding on your legacy

Consider your family, your community, what impact you wish to make and what you want to secure for the future. Talk to your loved ones about what you would like to do before finalising your Will.

You can give in different ways - leave the residue of an estate, a specific sum of money, a percentage of an estate, or a named item.

### How to leave a gift to Hospice in your Will

We recommend you go through a lawyer to ensure that your wishes are carried out the way you would like, and that your Will is legally valid - however that's up to you.

To leave a gift to charity you need to include the organisation's full name and registered Charity Number, and specify what you are giving, who can receive it, along with any special requests of its use.

### **Example wording**

I give to Hospice Eastern Bay of Plenty, Charity Registration Number CC23677 (*description of item*, *sum*, or % of estate) for (*general purposes/your "tagged" purpose"*), for which the receipt to the Chief Executive or other proper officer shall be a full and sufficient discharge to my trustees.
